## **ADDITIONAL INFORMATION:**

- All groups must have, and submit proof of, comprehensive general liability insurance with a minimum liability limit of \$2,000,000.
- A Church appointed Security Supervisor is required for all functions held at the Church outside of business hours (currently Monday to Friday, 8:30 am to 4:30 pm). If the Church Custodian or Sound System Technician is required (not available on Mondays) for a function held at the Church, charges will be as stated on the rental rate schedule.
- NEW\* Evening Door Security: Both the Cambridge St. and Bond St. doors will be locked after 7:10 PM, Mon-Thurs. This measure has been put in place to enhance the safety of our church and everyone inside. To accommodate late arrivals or parents picking up children, we have installed doorbells at both entrances. Our student supervisors will respond to the doorbell and ask visitors to identify their purpose before granting access. To assist our supervisors, please inform them in advance if someone from your group is expected to arrive after 7:10 PM. This will help us manage access efficiently and ensure everyone's safety.
- Consideration will be given to a reduced rental rate for organizations that require multiple consecutive dates.
- Set-up and take-down of tables and chairs is the responsibility of the persons/organization using the facilities. Any set-up/take-down of tables and chairs that is required of the Church Custodian (not available on Mondays) will be an extra fee of \$25.00 per hour.
